NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

MEMORANDUM OF THE TRUST

1. This Trust will be called as "AURA EDUCATIONAL TRUST".
2. This Trust shall be constituted and administered in accordance with the term of this DEED OF TRUST and rules and regulations framed hereunder:
3. This trust shall have its registered office at Seuj Nagar, Pathsala, Barpeta-781325 in the first instance OR at any other convenient place so decided from time to time by the Trustees.
4. AIMS AND OBJECTIVES OF THE TRUST ARE AS UNDER:
 - a. To manage and control the affairs of **PATHSALA PUBLIC SCHOOL**.
 - b. To provide, establish, maintain, control and manage schools and educational institutions and to do all such acts, deeds and things, as may be conducive for the growth and progress of the institutions.
 - c. To make provision and arrangements for imparting education in Arts, Science, Commerce and other subjects.
 - d. To hold and manage educational endowments, to erect, equip and maintain schools and colleges, laboratories, libraries and to make regulations relating to the residence and conduct of students, studying and residing in the institutions, maintained and managed by the Trust.
 - e. To patronize, encourage and grant stipends to poor and deserving students for higher education and specialized study in Science or technical subjects.
 - f. To print and publish books and literature.
 - g. To provide entertainment in the form of stories, folk songs, dances, recitations, literature, poetry, indoor and outdoor games, picnics, excursions and tours for the students.
 - h. To celebrate important days and festivals and to inculcate in the students the Sportsman spirit and Swadeshi ideas.
 - i. To work for National Integration and defence of the Country through education.
 - j. To entertain the students of the other parts of the Country with a view to provide education of Indian languages and Indian culture.
 - k. To send any member of the society to any part of the India and abroad for study tours.
 - l. To produce professionals with the assistance of qualified Instructors, Teachers, Professors, Artists, Medical practitioners and workers, both voluntary or otherwise
5. Working Hours of the Office will be from 10.30 AM to 6.00 PM with suitable intervals.
6. Administrative Year of the Trust will commence from 1st of April to 31st March of the next year.
